Danforth Avenue – Dawes to Victoria Park Watermain & Sewer Replacement, Sidewalk & Streetscaping Improvements

As part of the ongoing Danforth Avenue Improvements Project, the City of Toronto is planning watermain and sewer replacement work, sidewalk construction and streetscaping improvements along Danforth Avenue from Dawes Road to Victoria Park Avenue beginning July 14th, 2014. This phase of construction will also include work on Luttrell Avenue.

Construction Notification

Regular updates will be provided to the community. The project is divided into manageable staging work and the timeline of notification to the community will be based on the progress and start-up of the individual stages. Work Hours

Work will typically take place from 7:00 a.m. to 7:00 p.m., Monday to Friday, with work after hours and on weekends as required.

Disruptions

As with all construction projects, there will be noise and temporary inconveniences. In order to complete the work effectively and in a safe manner, some pedestrian and traffic restrictions will be necessary. These include restrictions to turning, parking and traffic lanes in and around the work area. Every effort will be made to reduce the inconvenience.

Traffic & Parking Restrictions

Luttrell Avenue will be closed to traffic for sewer and watermain replacement and road reconstruction. The City will be arranging alternative parking for residents on Luttrell Avenue. Those details will be provided in a separate notice and delivered to residents.

Danforth Avenue will be reduced to one lane of traffic in each direction. On-street parking on Danforth Avenue will be restricted during this period. No parking will be permitted in the active work zones.

Pedestrian traffic will be maintained at all times. Please cross the road safely at signalized intersections.

Deliveries to Businesses

Deliveries to the front of businesses within the work zone may need to be coordinated with the on-site City inspector. Visit the on-site City inspector at the site office located at 2828 Danforth Avenue, 2nd Floor or contact City staff listed below to make arrangements.

Items on City Property

Property owners in the work area are reminded to remove any privately owned items from the sidewalk area prior to sidewalk construction beginning. The City will not be responsible for damage to any privately owned items installed on City property.

Label Curbside Waste Collection Bins

Please continue to put out your garbage, recycling and green bins as per your normal schedule. If required, the contractor will temporarily move bins to an appropriate location and return them promptly.

Please label your bins with your address.

Please write your address number in large print on the bins to ensure they are returned to the proper unit.
