As part of the ongoing Danforth Avenue Improvements Project, the City of Toronto is commencing sidewalk replacement, streetscaping improvements and road resurfacing work along Danforth Avenue from Woodbine Avenue to Dawes Road beginning July 21, 2014.

Work Hours

Work will typically take place from 7:00 a.m. to 7:00 p.m., Monday to Friday, with work after hours and on weekends as required.

Disruptions

As with all construction projects, there will be noise and temporary inconveniences. In order to complete the work effectively and in a safe manner, some pedestrian and traffic restrictions will be necessary. These include restrictions to turning, parking and traffic lanes in and around the work area. Every effort will be made to reduce the inconvenience.

Traffic & Parking Restrictions

Traffic lanes on **Danforth Avenue** will be reduced in the work zone. On-street parking on Danforth Avenue will be restricted during this period. No parking will be permitted in the active work zones.

Pedestrian traffic will be maintained at all times. Please cross the road safely at signalized intersections.

Items on City Property

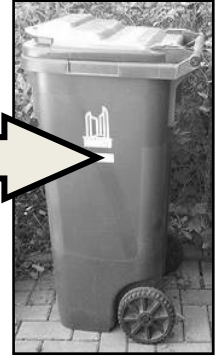
